Event Concession Vendor Contract

The Host and Vendor parties both agree to the following terms:

1. Vendor will be given access to the place that is agreed upon by both parties no less than 6 hours before the Event starts to set up the Vendor's station, goods to be sold, and anything else that is needed and customary to vend at that specific location. Vendor locations will be assigned on first come first serve basis.
2. The Vendor will not vend any items or services that are not disclosed here at the Event without prior written consent from the Host. Items that will be sold:

3. Vendor's station shall be no bigger than 10 x 10 feet unless prior approval is requested; and shall be

4. Vendor's staff may exhibit that goods are for sale only while the staff is within the area of the vendor's specified location.

5. Vendor's staff will be clean and neat and they shall conduct themselves in an orderly fashion.

6. Vendor will have access to the location for up to 8 hours following the Event has concluded at 12:00 PM 8/21/2011 to dismantle and remove all items brought to the Event by Vendor. Vendor shall leave the location free from trash and in similar condition that it was in before the Vendor was there.

7. Vendor agrees to hold the Host free from any damages or claims that may develop in connection with participating in the above mentioned Event.
